 Current CMP and NRA High Power Rifle rules will govern.

Entries:
Entries & Fees:
 Entries will be made at the firing line. Fee: \$20 adult or \$15 juniors. Entries close at 7:30 a.m.

Time of Firing:
 8 a.m. on all days; pits seal 7:45.
Safety brief 7:30.

Squadding:
 Individual matches will be squadded at the match, after entries close.

Classification:
 CMP & NRA classification will be used in all matches. Unclassified competitors will compete in the Master Class.

Scoring & Target Pulling Duties:
 Competitors are required to perform both scoring and target pulling duties.

Challenges:
 \$1 will be charged for lost challenges. Scores may be challenged only prior to awards.

Targets: 200 yd-SR, 300 yd-SR-3, 600 yd MR1

Equipment: Service Rifle; Match Rifle

The use of an Empty Chamber Indicator (ECI) is required.

Ammunition:
 Furnished by competitor; no tracers or armor piecing (AP) and no larger than 0.35 caliber.

Coaching:
 Allowed during the preparation and sighting period for NEW shooters and juniors only.

Course of fire:

Order of fire may vary (i.e. 600 may be first due to afternoon light conditions). Match Rules 6.1.3

Match 1- 10 or 20 record-standing, slow fire, 200 yds. SR target, Rule 6.1.1 (CMP)/7.14 & 10.1.6 (NRA)

Match 2- 10 or 20 record- sitting, rapid fire, 200 yds, SR target, Rule 6.1.2 (CMP)/7.14 & 10.1.7 (NRA)

Match 3- 10 or 20 record-prone rapid fire, 300 yds, SR-3 target. Rule 6.1.3 CMP/7.14 & 10.1.7 (NRA)

Match 4 -20 record-prone, slow fire, 600 yds, MR-1 or MR-1FC target, Rule 6.1.3 (CMP)/7.14 & 10.1.6 (NRA)

Match 6-80 shot aggregate – Regional Match Course

GSM course A: 30 rounds plus 5 sighting shots, Prone, Slow; Prone Rapid, Standing Slow

Awards: Competitors winning a place award will not receive a class award in the same match. Number of awards is determined by the number in the class </=5 = 1 award, 9 = 2. Awards may be donated to the range fund
