

# TEXAS STATE RIFLE ASSOCIATION (TSRA) 2021 HIGH POWER CHAMPIONSHIP

**Current CMP High Power Rifle rules will govern.**

*Competitors are responsible for being aware of the Match Program and all safety regulations contained in the CMP rulebook.*

Entries: Use the enclosed registration form and mail a check or money order payable to "PCGC Highpower Division" to PCGC TSRA Match 107 Belair St, Carthage, TX 75633. **Entries without payment will not be squadded.** Entries must be received by March 12, 2021. Late entries will be subject to a \$10 late fee. Cancellations after March 13, 2021, may NOT be refunded.

**Participants must be TSRA members. TSRA member applications will be available at the match.**

Team Entries: **Do not** prepay for the team match. Team entries and entry fees will be accepted on the day of the match.

Capacity: The maximum range capacity is 64 (4 relays). In the event that the matches fill past capacity, post marks will be used to determine squadding, and a standby list will be developed.

CMP Liability Release: A release must be on file with the CMP. If you need to complete a release form, you can find one at <http://thecmp.org/wp-content/uploads/affidavit.pdf>.

Time of Firing: Check-in closes at 7:00 a.m. Pits will be sealed at 7:15a.m. Firing will begin at 7:30 a.m. each day.

## Schedule of Events:

March 19, 2021	4-man Team Match (Cup Event Rule 5.7)
March 20, 2021	800-Point CMP Cup Match (Cup Event Rule 5.5)
March 21, 2021	EIC (Leg) Match (Rule 8.3)

Squadding: The 800-point CMP Cup Match will be pre-squadded with entry. Team and EIC matches will be squadded on the firing line. Pre-registration for the EIC match is preferred, but day-of entries will also be accepted.

Pit Service: Competitors will be required to perform scoring and pit duties. Paid pullers will not be provided.

Classifications: CMP or NRA classifications will be used in all matches. Unclassified competitors will compete in the Master Class.

Challenges: A \$2 Challenge Fee will be charged for lost challenges. Scores may only be challenged prior to awards.

Sighting Shots: 2 per stage - fired and scored in the individual matches. None in the LEG matches.

Targets: Targets to be used are the 200 yd-SR, 300 yd-SR-3, 600 yd MR1.

## **AWARDS**

Team Match: The top three teams, regardless of classification or rifle type, will be recognized.

### Individual Awards:

- The match winner of the 800-point CMP Cup Match will be the 2021 TSRA State High Power Champion regardless of type of rifle used, i.e., service or match.
- CMP Medals will be presented to the first, second, and third place winners, i.e., the top three scores, regardless of rifle type.
- Place awards will be made by rifle type, provided that there are five entries within a particular rifle type.
- Classification awards will also be made provided that there are a minimum of five competitors within that classification. Classes will be combined upward as required except that the High Master class will not be combined. If less than 5, the High Master classification will fire for place awards only. Competitors winning a place award will not receive a class award in the same match.
- The number of awards is determined by the number in the class. Second, third, fourth place, etc., awards will be given based on one award for each five (5) competitors, i.e., second 6-10; third 11-15, etc.
- Special awards for High Senior, High Junior, and High Woman will be recognized only if there are three (3) or more in that category. Match winners are not eligible for special awards.

CMP EIC match: Awards will be determined and awarded by the CMP pending the review of match results.

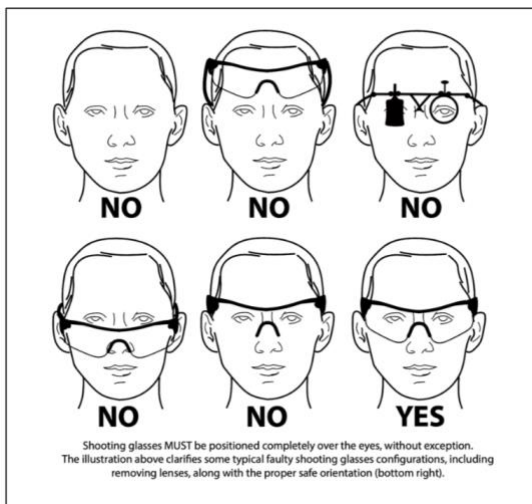

**Highlighted Safety Notes** – competitor is responsible for **ALL** published CMP and posted range-specific rules

- The use of an empty chamber indicator (ECI) is required at all times even while the rifle is in the case. Only during a preparation period or actual firing may the ECI be removed from the rifle.
- Level-loading is required. The rifle must be pointed at the berm or lower while being loaded and while closing the bolt.
- Hearing protection, eye protection, and a billed hat are required in the pits.
- **CMP EYE PROTECTION RULE CHANGE**

3.6.2 Eye and Hearing Protection All competitors and competition officials, including Scorers or Verifiers, are required to wear eye and hearing protection when on shooting range firing lines during highpower rifle firing. Eye protection must have two complete lenses with minimum dimensions in depth and width for each lens of 1.30 in. It is strongly recommended that eyewear worn on firing lines meet or exceed the ANSI Z87.1 safety standard impact protection. Competitors' eyewear must be worn so that the two lenses remain in front of the eyes during firing (see diagram). No one will be allowed to participate in a CMP-sanctioned competition unless they are wearing eyewear and hearing protection that complies with this rule. Any competitor or match official who is not in 19 compliance with this rule will be warned in accordance with Rule 3.12.2 a). Refusal to comply with a warning is grounds for disqualification.
